Overstay visitors incur to pay a penalty of US\$ 20,- per day (for under 60 days stay) whilst over 60 days stay will be a 5 (five) year prison sentence or a fine of IDR 25.000.000,- (local currency).

Cost for Visa-On Arrivals are US\$10 for a stay of up to 3 days, US\$25 for a stay of up to 30 days.

Entry Requirements For Visa On Arrival (VOA)

1. Passport must be valid for a minimum of 6 (six) months as from the date of entry into Indonesia
2. Onward or return tickets are compulsory
3. No compulsory vaccinations

The Visa purchasing system will take approximately 3-5 minutes per applicant. There are 6 payment counters, a bank and a money changer set up to process payments.

You are advised to change your money into US\$ prior to arriving in Bali to pay for your visa on arrival.
